# Research Fellow in Childhood and Youth School of Education, Faculty of Education, Social Sciences and Law

Are you an ambitious early career researcher with a track record in high-quality research on education and contemporary challenges children and young people are facing locally and/or globally? Do you have experience of writing high-quality research funding applications or organising cross-sectoral projects aiming at achieving broader impact beyond academia? Do you want to further your research career in one of the UK's leading research-intensive Universities?

Applications are invited for a Post-Doc Research Fellowship in the Centre for Childhood, Education and Social Justice to:

- (a) Develop and support research funding applications in collaboration with colleagues within the Centre, and
- (b) Support existing research as well as conduct new primary research, which may involve relevant fields such as education, psychology, sociology and anthropology of childhood as well as inter- and trans-disciplinary collaboration.

You will have experience of writing high-quality research funding applications and undertaking research and/or of organising cross-sectoral projects addressing contemporary challenges children and young people are facing locally and/or globally.

While this position requires full time presence at the University of Leeds, some travel within the United Kingdom and overnight stays will be involved and travel overseas may also be required. You will possess excellent written and verbal communication skills and will demonstrate an ability to work both independently and collaboratively as part of a team.

As part of your application, please could you submit copies of your two strongest publications? These should represent your best work in terms of originality, significance and rigour and both should be published since January 2014. One could be a draft that has been submitted or is close to submission.



## What does the role entail?

As a Research Fellow in Childhood and Youth your main duties will include:

- Collaborating on research, publication and impact-related activities addressing education and contemporary challenges children and young people are facing locally and/or globally;
- Developing, supporting and writing proposals for research and impact funding in collaboration with colleagues within the Centre for Childhood, Education and Social Justice:
- Being an active researcher, conducting primary research, planning and undertaking fieldwork, designing research instruments and analysing data;
- Preparing and collaborating on papers for publication in major refereed journals;
- Drafting project reports and presenting research findings to academic and professional audiences, communicating complex data in accessible ways;
- Maintaining an up to date knowledge of relevant literature and of developments in education and training;
- Participating actively as a member of the Centre for Childhood, Education and Social Justice as well as the broader School of Education:
- Contributing to the development of the Centre profile, nationally and internationally;
- Using your initiative and creativity to identify areas for research and channels for impact, seeking opportunities for interdisciplinary work within Leeds Social Sciences Institute and across the university;
- Contributing to teaching at a variety of levels within the School of Education (as part of your academic development).

#### Your time will be shared between:

- a) supporting existing research and conducting new primary research and publishing research findings, and
- b) developing and supporting research and impact funding applications from colleagues within the Centre for Childhood, Education and Social Justice.

These duties provide a framework for the role and should not be regarded as a definitive list. Other reasonable duties may be required consistent with the grade of the post.



# What will you bring to the role?

As a Research Fellow in Childhood and Youth you will have:

- A first degree and a doctorate in the field of education (or a relevant social science discipline) or a relevant postgraduate qualification in education (or a relevant social science discipline) with advanced research skills and training;
- Ability to contribute to the international profile of the School of Education within the field of Childhood and Youth;
- A clear research agenda in relation to education and contemporary challenges children and young people are facing locally and/or globally;
- Experience of carrying out high-quality research on education and contemporary challenges children and young people are facing locally and/or globally;
- A record of, or demonstrated potential for, producing internationally excellent research outputs in relation to contemporary challenges children and young people are facing locally and/or globally;
- A record of, or demonstrated potential for, developing and writing collaborative highquality research applications and for securing substantial external research or impact funding;
- The ability to teach aspects of core modules on the BA Childhood Studies;
- Excellent time management and planning skills, with the ability to work effectively under pressure;
- Excellent written and verbal communication skills, including giving presentations and engaging effectively with a wide range of stakeholders;
- A proven ability to work well both independently and in a team.

#### You may also have:

- Experience of participation in large-scale externally-funded research projects and teams:
- Experience of cross-sectorial, policy and impact-related funding and projects, including collaboration with NGOs, industry partners, policy makers or other relevant stakeholders.
