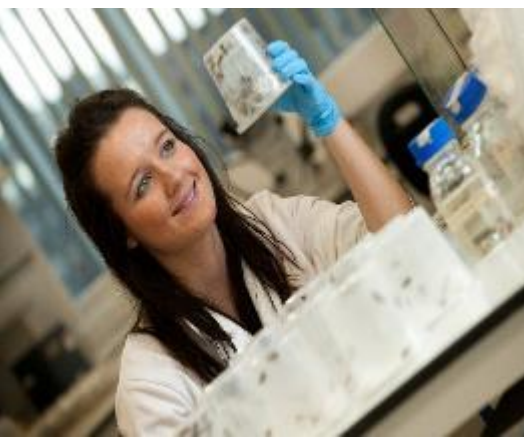
Are you an ambitious researcher looking for your next challenge? Do you have an established background in Bioinorganic Chemistry, Bionanotechnology or Bioelectrochemistry? Do you want to further your career in one of the UKs leading research intensive Universities?

You are invited to join an interdisciplinary [BBSRC](#)-funded project to develop novel biotechnologies to harness the power in sunlight and drive energy demanding and complex chemical transformations in a sustainable way. Specifically, and inspired by natural photosynthesis, we aim to provide proof-of-principle for whole-cell biohybrid photocatalysis, in which bespoke photocatalysts are directly coupled to the respiratory machinery and metalloproteins of bacteria *in vivo*.

This BBSRC-funded project is a collaboration between the Universities of Leeds, East Anglia and Cambridge. You will be based in a multidisciplinary research team supervised by [Professor Lars Jeuken](#) and will work in collaboration with [Professor Julea Butt](#), University of East Anglia and [Professor Erwin Reisner](#), University Cambridge.

You should have, or be close to completing a PhD in a relevant subject area (e.g. chemistry, biochemistry, biophysics). With a background in bioinorganic chemistry, bionanotechnology or bioelectrochemistry you should be able to work effectively both independently and within a multidisciplinary team.

The University of Leeds and the Faculty of Biological Sciences are committed to providing equal opportunities for all and offer a range of family friendly policies. What does the role entail?

As a Research Fellow your main duties will include:

- Designing, planning and conducting a programme of investigation, in consultation with [Professor Lars Jeuken](#);
- Generating independent and original research ideas and methods in bioinorganic chemistry, bionanotechnology and bioelectrochemistry with an aim to extend the research portfolios of the [Jeuken group](#) and collaborators in East Anglia and Cambridge;
- Making a significant contribution to the dissemination of research results by publication in leading peer-reviewed journals, and by presentation at national and international meetings;
- Working independently and as part of a larger team of researchers, both internally and externally to develop new research links and collaborations and engage in knowledge transfer activities where appropriate;
- Contributing to the supervision of junior researchers and PhD students and acting as a mentor to less experienced colleagues;
- Evaluating methods and techniques used and results obtained by other researchers and relating such evaluations to your own research;
- To contribute to, and to encourage, a safe working environment.

These duties provide a framework for the role and should not be regarded as a definitive list. Other reasonable duties may be required consistent with the grade of the post.

What will you bring to the role?

As a Research Fellow you will have:

- A PhD (or close to completion) in Chemistry, Biochemistry, Biophysics or a closely allied discipline;
- Experience in Bioinorganic Chemistry, Metalloproteins, Bionanotechnology, Bioelectrochemistry or Biological electron transfer;
- Strong analytical skills, with the ability to work accurately and carefully, designing, executing and writing up research independently;
- A developing track record of peer reviewed publications in international journals;



- Excellent communication skills, both written and verbal and the ability to communicate your research at national and international conferences;
- The ability to work well both independently and as part of a team;
- Strong initiative and a pro-active approach, with excellent organisational, planning and self-management skills, including the ability to prioritise workloads to meet deadlines/demand and deliver high quality under pressure;
- A strong commitment to your own continuous professional development.

You may also have:

- Experience in fluorescence lifetime measurements, photocatalysis or photosynthesis;
- Evidence of pursuing external funding to support research.

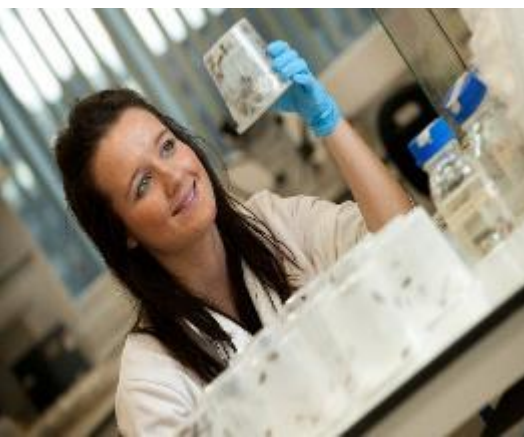
