**Are you an academic with proven abilities to carry out teaching and research in international business and related topics? Do you have an excellent research record and proven success with obtaining funding? Do you have strong methodological skills? Are you passionate about delivering an exceptional student experience in a research-intensive Russell Group University?**

As Lecturer, you will carry out research, teaching and management within the school, faculty and university, and contribute to academic leadership in the field of business with specific emphasis on international business.

The International Business Division at Leeds University Business School has global recognition for the quality of its research and teaching. This highly successful division is in the process of expanding. Independent assessments have ranked the International Business Division as the first International Business centre in the world and second in the world for leadership in international business research. Within the University of Leeds, the Division has been designated as a Gold Peak of Excellence for the outstanding international calibre of its research.

### **What does the role entail?**

As a Lecturer in International Business your main duties will include:

- Being actively involved in research, innovation and impact at national and international levels as well as, contributing to local School/Faculty activities;
- Maintaining a record of high quality publications of national and international standing;
- Attracting research funding individually and collaboratively to underpin high quality research activity and research programmes/projects;
- Promoting the integration of your own research area with other research interests within and, as appropriate, outside the School and Faculty;
- Providing research supervision and helping to attract students to the University;
- Undertaking research-led teaching at different levels, including assessment and examination, and contributing towards module design, review and quality assurance mechanisms;



- Providing support and guidance to students, giving timely feedback, acting as a personal tutor, resolving issues and/or referring to specialist parties, where appropriate;
- Contributing effectively to the administrative processes and committee structures of the School/Faculty, including taking on leadership roles and managing initiatives that facilitate School, Faculty or University performance or business.

These duties provide a framework for the role and should not be regarded as a definitive list. Other reasonable duties may be required, consistent with the grade of the post.

## **What will you bring to the role?**

As a Lecturer in International Business you will have:

- A PhD in Business, Management, Economics or a closely related discipline (or PhD submitted by the start date of the post);
- A track record of publications in refereed journals commensurate with a 3 or 4 star rating as defined by the REF and as evidenced by metrics such as the Association of Business Schools journal quality list, the FT45 list or other equivalent sources;
- Strong skills in research methodologies (e.g. data analysis and modelling);
- A successful record of obtaining external research funding with the potential for obtaining further funding in the future;
- The ability to contribute to and develop interdisciplinary collaborative research projects in a broad range of areas;
- A proven record of teaching in a university environment, with an enthusiastic approach to teaching international business and the ability to interact with students in ways that will enhance the student experience;
- Experience of proactively developing new teaching approaches and materials in the area of international business;
- Exceptional communication skills with the ability to collaborate with peers and inspire your research colleagues;
- The ability to contribute to management and administrative processes and structures, including managing resources and/or staff.

- Experience of postgraduate student supervision;
- Experience of programme/academic leadership.
