Teaching Assistant or Fellow in Computer Science

School of Computing

Are you enthusiastic about teaching Computer Science? Are you looking for an opportunity to develop your teaching skills in Higher Education? Do you have the skills to engage, enthuse and motivate students?

The School of Computing is seeking to recruit excellent teaching staff to enhance the development and delivery of our programmes and extend our outreach activities. The role will require you to develop and deliver both practical and tutorial classes across a variety of modules on our computer science programmes. This includes modules such as programming, software engineering, databases and computer architecture. You will also be involved in the design and marking of assessments and worksheets and work with the University's outreach team to develop resources for public-facing projects.

You will have an undergraduate or masters degree in Computer Science or in a demonstrably relevant subject area, with an enthusiastic, creative approach to transferring knowledge and skills to students.

What does the role entail?

As a Teaching Assistant, your main duties will include:

- Providing inspirational teaching and learning, which reflects professional standards and industry good practice;
- Supporting and delivering modules, including lectures, examples classes, tutorials and laboratory work at different levels on undergraduate and/or postgraduate taught courses;
- Assessing students' work, including marking exams and coursework;
- Assisting with laboratory classes and exercises, and helping students with project work;
- Utilising innovative approaches to learning and teaching with a strong emphasis on blended learning approaches;
- Providing timely feedback to students on their studies, identifying the learning needs of students and defining appropriate learning objectives;
- Providing advice to students on matters relating to their orientation to UK academic expectations, their studies and be available to students at agreed times outside of the teaching schedule;



- Contributing to the review of modules and programmes and to quality assurance mechanisms.

In addition, as a Teaching Fellow your main duties will also include:

- Developing innovative approaches to learning and teaching with a strong emphasis on blended learning;
- Setting exams and coursework;
- Acting as a personal tutor, including pastoral care and supporting students in maximising the benefits of their time at Leeds.

These duties provide a framework for the role and should not be regarded as a definitive list. Other reasonable duties may be required consistent with the grade of the post.

What will you bring to the role?

As a Teaching Assistant at grade 6 you will have:

- An undergraduate or masters degree in Computer Science or in a demonstrably relevant subject area;
- The ability to motivate and engender enthusiasm in others, as evidenced for example in student feedback obtained from previous teaching experience, with an enthusiastic, creative approach to transferring knowledge and skills to students;
- Experience of the delivery of teaching materials in a Higher Education setting, demonstrating effective teaching skills;
- Excellent team-working and networking skills;
- Demonstrate excellent communication and interpersonal skills, with a flexible, motivated and co-operative approach and good time management skills;
- Evidence of a proactive approach to further learning and personal development training;
- A commitment to a positive, inclusive and equal working environment

Additionally, as a Teaching Fellow at grade 7 you will have:

- A masters or PhD degree (or be close to completion of a PhD) in Computer Science or in a demonstrably relevant subject area;



- Experience of the design, development and delivery of teaching materials in a Higher Education setting;
- Demonstration of effective teaching and practical skills and a range of delivery techniques and assessment methods to teach effectively at all levels.

At both grades, you may also have:

- Experience of developing and incorporating innovative approaches to teaching or assessment;
- Experience of applying research and scholarship in teaching.
