**Are you an academic with proven abilities to carry out teaching and scholarship in the field of applied theatre? Can you pursue, develop and take forward pedagogic developments? Are you passionate about delivering an exceptional student experience in a research-intensive Russell Group University?**

You will carry out teaching and scholarship in varying aspects of applied theatre and contribute to the effective management of the School, Faculty and wider University. You will be expected to undertake the normal range of duties that arise in connection with the teaching of undergraduate and postgraduate modules, including lecturing, seminar delivery, workshop practice, dissertation supervision and assessment. You will serve as a committed personal tutor and be able and willing to support undergraduates and postgraduates effectively throughout their studies.

With relevant teaching experience and a PhD in a field broadly related to applied theatre, you will be passionate about delivering an exceptional student experience.

### **What does the role entail?**

As a Lecturer in Applied Theatre, your main duties will include:

- Undertaking teaching at all levels of our taught programmes, including assessment and examinations, contributing towards module design, review and quality assurance mechanisms;
- Contributing to the development of research-based, theoretically informed and innovative approaches to learning and teaching;
- Delivering high quality workshop sessions for students and supervising studio practice that leads to participatory and/or externally facing work;
- Providing support and guidance to students, providing timely feedback, acting as a personal tutor, resolving issues and/or referring to specialist parties, where appropriate;
- Participating in the effective supervision of Undergraduate and Postgraduate students undertaking dissertations/projects as required;



- Conducting individual or collaborative scholarly projects to contribute to the strategic agenda and priorities of the Institute;
- Contributing effectively to the administrative processes and committee structures of the School, Faculty and University and contributing to the initiatives which facilitate School, Faculty or University performance or business.

These duties provide a framework for the role and should not be regarded as a definitive list. Other reasonable duties may be required consistent with the grade of the post.

## What will you bring to the role?

As a Lecturer in Applied Theatre, you will have:

- A PhD (awarded prior to application closing date), in a field related to applied theatre or to a cognate discipline;
- Evidence of your own practice as an applied theatre practitioner and how that contributes to effective teaching and learning strategies;
- Expertise and interests in the field of applied theatre, including in at least two of the following areas: performance and social change; performance and social/cultural activism; political theatre; performance in community contexts; theatre and intervention; theatre and education; theatre in the criminal justice system; theatre and health; theatre and development;
- A commitment to scholarly excellence in the subject specific area including the development of creative and innovative teaching methodologies including the effective use of new and creative learning and teaching technologies;
- A proven record of teaching in a University environment, with an enthusiastic approach to teaching and the ability to interact with students in ways that will enhance the student experience;
- Experience of proactively developing new and innovative teaching and assessment approaches and materials;
- The ability to work with a team of colleagues and to manage commitments in a timely and strategic manner;
- The ability to contribute to management and administrative processes and structures;



- Excellent communication and IT skills to support and enhance teaching and research.

You may also have:

- Experience of teaching international students;
- Module management experience;
- Experience of supervising Masters level dissertations.
