Lecturer in Ecological and/or Environmental Economics School of Earth and Environment, Faculty of Environment

Are you an academic with proven abilities to carry out teaching and research in ecological and/or environmental economics? Do you have an excellent research record and proven success obtaining funding? Are you passionate about delivering an exceptional student experience in a research-intensive Russell Group University?

The Sustainability Research Institute (SRI) in the School of Earth and Environment is looking for an enthusiastic and self-motivated environmental social scientist with a focus on ecological and/or environmental economics to join our world-leading team of researchers. Following recent successes in student recruitment and grant income from a range of funders, we are seeking to build our portfolio of excellent teaching and research in ecological and/or environmental economics. We are specifically looking for someone whose work complements, and adds depth and breadth to that of our current team.

SRI is an internationally leading centre for research in the environmental social sciences. Our research groups include economics and policy for sustainability; business and organisations for sustainable societies; environment and development; energy and climate change mitigation; social and political dimensions of sustainability; and climate change adaptation, vulnerability and services.

For this position, we are particularly interested in candidates with expertise in the broad field of ecological and/or environmental economics. Successful candidates will need to show a proven track record of publications and funding applications. A willingness to work in collaboration with colleagues across the institute and wider University is also essential.

You will contribute to student education across the School's undergraduate and Masters Sustainability programmes that focus on ecological economics, sustainability and business, and sustainability and consultancy. This will include research dissertations, field courses, and placement projects.



What does the role entail?

As a Lecturer, your main duties will include:

- Undertaking innovative and collaborative research in the broad field of ecological and/or environmental economics;
- Leading and contributing to module/programme management and teaching at Undergraduate and Master's level. This will centre on Undergraduate programmes such as the Environment and Business BA, and Master's level programmes such as the Ecological Economics MSc, Sustainability and Business MSc, and Sustainability and Consultancy MSc, and contributing to other research-led teaching as appropriate (including developing fully on-line courses);
- Being actively involved in research, innovation and impact at a national and international level, as well as contributing to local School/Faculty activity;
- Maintaining a record of high quality publications of national and international standing;
- Attracting research funding individually and collaboratively to underpin high quality research activity and research programmes/projects;
- Promoting the integration of your own research area with other research interests within and, as appropriate, outside the School and Faculty;
- Providing research supervision and helping to attract students to the University;
- Undertaking research-led teaching at different levels, including assessment and examinations and contributing towards module design, review and quality assurance mechanisms;
- Providing support, guidance and timely feedback to students, acting as a personal tutor, resolving issues and/or referring to specialist parties, where appropriate;
- Contributing effectively to the administrative processes and committee structures of the School/Faculty including taking on leadership roles and managing initiatives which facilitate School, Faculty or University performance or business.

These duties provide a framework for the role and should not be regarded as a definitive list. Other reasonable duties may be required by the Head of School consistent with the grade of the post.



What will you bring to the role?

As Lecturer you will have:

- A PhD in any subject area within the broad field of ecological and/or environmental economics;
- A track record of research outputs in ecological and/or environmental economics, within refereed publications of internationally excellent quality;
- A successful record of obtaining external research funding in the ecological and/or environmental economics subject area with the potential for obtaining further funding in the future;
- A commitment to research impact, locally or internationally;
- An ability to contribute to and develop interdisciplinary collaborative research projects in a broad range of areas within the field of ecological and/or environmental economics;
- A proven record of teaching in a University environment (including managing modules, courses), with an enthusiastic approach to teaching in the general field of ecological and/or environmental economics and the ability to interact with students in ways that will enhance the student experience;
- Experience of proactively developing new teaching approaches and materials in ecological and/or environmental economics;
- A high level of interpersonal and communication skills, and a strong ability to communicate effectively in writing and verbally with students, academic and external audiences;
- An ability to contribute to management and administrative processes and structures, including managing resources and/or staff.

You may also have:

- An ability to teach at a University level in the fields of business and sustainability and/or sustainability and consultancy;
- Evidence of working in low and middle income countries with an active network of collaborators and partners;
- Research expertise, or experience that would enable you to work collaboratively with researchers across the wider University Research Platforms (e.g. Priestley International Centre for Climate; Global Food & Environment Institute, water@leeds or Leeds Institute for Data Analytics);
- Experience of on-line delivery of short courses or modules;
- Experience of providing postgraduate student supervision;



- Experience of contributing to academic leadership.
