Are you an academic with proven abilities to carry out teaching and research in the fields of museum and heritage studies? Do you have a research strength in the area of heritage, interpretation, participation and digital? Are you passionate about delivering fantastic learning experience for MA students?

You will carry out research and teaching in varying aspects of museum and heritage studies and contribute to the effective management of the School, Faculty and wider University. In particular you will teach on our MA in Art Gallery and Museum Studies, MA in Arts Management and Heritage Studies and MA in Curating Science on our core modules Critical Issues and Interpretations. You will have expertise in Critical Heritage Studies, ideally with an interest in participation and digital heritage.

You will be developing a track record in high quality research outputs and in attracting funding to support your developing research agenda.

You will also be expected to undertake the normal range of duties that arises in connection with the teaching of undergraduate and postgraduate modules, including lecturing, seminar delivery, dissertation supervision and assessment.

With relevant research and teaching experience and a PhD, you will have the ability to make an outstanding contribution to the dynamic research life of the School and you will be passionate about delivering an exceptional student experience.

What does the role entail?

As a Lecturer, your main duties will include:

- Undertaking teaching at all levels of our taught programmes, including assessment and examinations, contributing towards module design, review and quality assurance mechanisms;
- Providing support and guidance to students, providing timely feedback, acting as a personal tutor, resolving issues and/or referring to specialist parties, where appropriate;



- Pursuing and maintaining a record of high quality publications and original research publications suitable for inclusion in the School's submission to the Research Excellence Framework (REF);
- Developing bids for grant capture to underpin high quality research activity and to support a developing research agenda;
- Promoting the integration of your own research area with other research interests within, and, as appropriate, outside the School and Faculty;
- Contributing effectively to the administrative processes and committee structures of the School, Faculty and University;
- Providing research supervision and helping to attract PhD students to the University.

These duties provide a framework for the role and should not be regarded as a definitive list. Other reasonable duties may be required consistent with the grade of the post.

What will you bring to the role?

As a Lecturer, you will have:

- A PhD in a field related to museum and heritage studies;
- Expertise and research interests in the field of heritage, interpretation, participation and digital;
- An emerging track record of research outputs commensurate with career stage and have a clear indication of future plans and the potential to achieve the very highest standards of research in the field of museum and heritage studies;
- A proven record of teaching in a University environment, with an enthusiastic approach to teaching and the ability to interact with students in ways that will enhance the student experience;
- Experience of proactively developing new and innovative teaching and assessment approaches and materials;
- The ability to work with a team of colleagues and to manage commitments in a timely and strategic manner;
- The ability to contribute to management and administrative processes and structures;
- Excellent communication and IT skills to support and enhance teaching and research.
