## Overview of the Role

Are you an exceptional graduate looking for an exciting challenge? Are you enthusiastic, well organised and versatile, with the ability to support research in a collaborative research team? Do you want to use your food science laboratory skills and experience to help our academic staff deliver an excellent research experience?

We are seeking a Research Support Officer to join our team based at the School of Food Science and Nutrition working on the Canada-UK: Plant-based Protein Innovation funded Innovate UK project. This bilateral consortium aims to improve region-specific agronomy traits of lupin production, the crop's direct utilisation in the form of a wide range of ingredients (proteins, lipids, fibres) and the application of these ingredients into a region specific (North America and UK/Europe) food product portfolio.

As a Research Support Officer you will characterize a range of plant protein lupin ingredients with a wide range of biochemical, chromatographic and enzymatic techniques. You will also be actively maintaining communications relevant to the research activities, maintaining standard operating procedures (SOPs) and risk assessments for the project, keeping accurate records of all activities and periodic reports for the project team with the supervision from researchers on the project.

You will have experience of working within a research or academic administrative environment, alongside BSc in a relevant subject. You will also have good organisational and communication skills, and the ability to work on your own initiative and as part of a team.

# Main duties and responsibilities

- Producing plant protein ingredients by means of different extraction methods;
- Performing assays to assess the nutritional, antinutritional and techno functional properties of lupin ingredients;
- Performing protein digestibility assessments of lupin ingredients;
- Preparing reports for laboratory work, materials and protocols as required, and preparing project progress updates and feedback in a timely manner;
- Liaising with research team members, ensuring excellent communication;



- Providing health and safety and data security inductions and training for new members;
- Contributing to the health and safety assessment of the research team as required, including COSHH, SOPs, data and risk assessments;
- Working independently and also as part of a larger team of researchers, engaging in knowledge-transfer activities where appropriate and feasible;
- Continually updating your knowledge, understanding and skills in the field in which you work.

These duties provide a framework for the role and should not be regarded as a definitive list. Other reasonable duties may be required consistent with the grade of the post.

## **Qualifications and skills**

### Essential

- An undergraduate degree in Food Science, Food Biochemistry or Food Biotechnology or a relevant field, or equivalent relevant experience;
- An interest in producing plant protein ingredients;
- Strong analytical skills, with experience in the following methods: protein determination, sds-page, solubility, gelling properties, enzymatic hydrolysis, nutritional and anti-nutritional assessment;
- Working experience within a research or teaching environment;
- Excellent interpersonal and communication skills, including the ability to maintain strong working relationships with colleagues at all levels;
- Well-developed writing skills and a proven ability to produce reports of a high standard;
- Experience of working proactively and effectively, both independently and as part of a team;
- Excellent organisational skills, with a proven ability to prioritise and plan your work independently to tight deadlines, and to manage conflicting priorities;
- Excellent IT and administration skills, including a high level of proficiency in using Microsoft Office suite (Word, Outlook, Excel);
- A willingness to develop within the role, proactively identifying appropriate training in personal and professional development.



### Desirable

- A postgraduate degree in a relevant subject i.e. Food Science, Food Biochemistry or Food Biotechnology; or equivalent relevant experience;
- Experience in an administrative role including health and safety management within a UK Higher Education.
