

# **Aviation Assurance Manager, National Centre for Atmospheric Science, Faculty of Environment**

## Overview of the Role

Do you have experience working in quality assurance? Are you looking for an exciting opportunity to play a central role in developing and implementing new approaches to quality assurance? Would you relish the chance to contribute to the successful operation of a unique atmospheric science research facility? If so, we want to hear from you!

The <u>FAAM Airborne Laboratory</u> (FAAM) is a world-class research facility dedicated to the advancement of atmospheric science. We operate a specially adapted research aircraft managed by a unique team of scientists, engineers, flight technicians and project managers, providing a complete package of support for the scientific community.

The capabilities are extensively reliant on state-of-the-art scientific instrumentation, often uniquely customised for use on the aircraft, which is deployed throughout the world. All the science instrumentation and electronics is certified under CAA regulations to be safe for aviation applications in a safety-critical environment.

We operate within a complex contractual and regulatory environment. The aircraft is owned by UK Research and Innovation (UKRI); funded by the Natural Environment Research Council (NERC); leased by the University of Leeds; certified, maintained and operated by a commercial organisation; and managed on behalf of all parties by the National Centre for Atmospheric Science (NCAS). FAAM is currently undertaking a £49m Mid-Life Upgrade (MLU) to deliver a range of upgrades and enhancements to the aircraft, instrumentation, ground-based infrastructure and team, extending its useful operating life to 2040.

As FAAM Aviation Assurance Manager, you will lead and further develop the assurance of the FAAM Enterprise. Working closely with the Head of FAAM and supported by NERC-appointed aviation safety and assurance specialists, you will provide assurance to the aircraft owners and funders, aircraft leaseholder, and users. You will work with commercial partners including the type certificate holders, maintenance providers and aircraft operators. You will be a key member of the FAAM leadership team and will work with colleagues who specialise in operations,



instrumentation, technical coordination, safety and environmental sustainability, to develop and manage assurance in every aspect of FAAM operations, including the £49m Mid-Life Upgrade Project.

The role provides an exciting opportunity for an experienced quality assurance professional to identify, develop and implement quality assurance systems, processes and standards across all areas of FAAM operations. You will have excellent facilitation, diplomacy and communication skills, and will be adept at nurturing and maintaining a complex network of stakeholders. In return, we offer a friendly and supportive working environment where you will be actively encouraged to develop your professional skills and competencies.

Although the role will be employed by the University of Leeds, it will be wholly embedded within the FAAM team based at Cranfield University.

## Main duties and responsibilities

- Representing the FAAM Enterprise at the UKRI-NERC Aviation Assurance Panel (AAP), leading FAAM's submission including written documentation, presentations and verbal delivery to a range of senior stakeholders;
- Ensuring that assurance and quality management is embedded across all areas of FAAM operations;
- With support from NERC appointed aviation safety and assurance specialists, lead the management, development and presentation of FAAM assurance, based on a safety case methodology, addressing all aspects of FAAM;
- Work with enterprise stakeholders to develop and record structures and processes that meet the needs and expectations of the UKRI-NERC AAP;
- Developing and conducting internal audits to all areas of FAAM operations from an assurance perspective, making recommendations and supporting colleagues in delivering on those recommendations;
- Delivering a summary of FAAM assurance to NCAS and the University of Leeds to ensure their understanding and confidence of FAAM and its assurance processes;
- Working with NERC appointed aviation safety and assurance specialists to continually update and evaluate assurance activities and provision for FAAM operation in the changing aviation and research environment;
- Leading the annual UKRI-NERC assurance reporting process, demonstrating delivery against agreed targets as a part of NERC's large research infrastructure;



- Understanding and monitoring the legal and regulatory framework that FAAM operates the aircraft within;
- Assuring FAAM staff competence against a pre-determined framework, including ensuring all new starters receive appropriate induction training.

These duties provide a framework for the role and should not be regarded as a definitive list. Other reasonable duties may be required consistent with the grade of the post.

## **Qualifications and skills**

#### Essential

- Proven experience as a quality assurance manager or relevant role;
- Thorough knowledge of methods of quality assurance and standards (e.g., ISO9001, ISO45001);
- Understanding of risk management principles and techniques to support an operations safety case;
- A background in aviation, aviation related industry or other highly regulated industry requiring high levels of assurance;
- The ability to be firm in conviction, promote a "just and fair culture" and advance an open and non-punitive atmosphere for reporting, promoting a culture of respect through effective use of support and challenge;
- Excellent facilitation, diplomacy and communication skills, with a proven ability to work well both individually and in a team including working with a variety of complex stakeholders.

#### Desirable

- Lead auditor (or equivalent) qualification (e.g., IRCA certified);
- Sound knowledge of UK CAA aviation regulatory frameworks, including aircraft certification and flight test;
- Qualification/experience as a risk/safety manager, especially with an operations/safety case focus.

## Additional information
