## Overview of the Role

Are you an ambitious researcher with a commitment to promoting positive social change? Are you passionate about delivering innovative student education in a research-intensive university? Does your research and teaching offer important new insights into AI and social justice, with a focus on securitisation, the future of work, humanitarianism, politics/geopolitics, or activism? Do you have a demonstrable commitment to promoting equity, diversity, and inclusion in research and student education?

The <u>School of Geography</u> is home to the *Social Justice, Cities, and Citizenship (SJCC) Cluster*, where, in the context of increasingly diverse societies, unequal cities and uneven impacts of climate change, we develop innovative research, often in collaboration with civil society organisations and community groups to overcome discrimination, injustice and disempowerment and to achieve a fairer world. We are involved in a variety of local to international research partnerships from small NGOs to government departments. This work is underpinned by our successful record of external funding from a variety of national and international sources such as UK research councils, European Union, British Academy and the charitable sector. Colleagues in the School collaborate widely across campus and are actively involved with interdisciplinary initiatives and programmes such as the <u>Leeds Social Sciences Institute</u>, the <u>Futures Institutes</u>, the <u>Leeds Migration Research Network</u>, the <u>Global Food and Environment Institute</u>, and the <u>MSc in Sustainable Cities</u>.

Building on these strengths, we are seeking a new colleague to produce innovative research and teaching on critical geographies of artificial intelligence and social justice. Areas of potential expertise could include: Al and securitisation; Al and the future of work; Al and humanitarianism; the politics/geopolitics of Al; algorithmic activism. Applicants should also have the ability to teach across a broad human geography curriculum (including the use of qualitative methods) and be willing to contribute to new postgraduate programme developments. The SJCC Cluster is also a leader in promoting equity, diversity, and inclusion (EDI) in the School, Faculty, and beyond across a range of characteristics (including gender, disability, race, ethnicity,



religion, sexual orientation, and gender identity), and we are seeking a colleague who shares this commitment.

## Main duties and responsibilities

- Being actively involved in research, innovation and impact at a national and international level, as well as contributing to local School/Faculty activity;
- Maintaining a record of high quality publications of national and international standing;
- Attracting research funding individually and collaboratively to underpin high quality research activity and research programmes/projects;
- Promoting the integration of your own research area with other research interests within and, as appropriate, outside the School and Faculty;
- Providing research supervision and helping to attract students to the University;
- Undertaking research-led student education at undergraduate and postgraduate levels, including assessment and examinations and contributing towards module design, review and quality assurance mechanisms;
- Providing support, guidance and timely feedback to students, acting as a personal tutor, resolving issues and/or referring to specialist parties, where appropriate;
- Contributing effectively to the administrative processes and committee structures of the School/Faculty including taking on leadership roles and managing initiatives which facilitate School, Faculty or University performance or business.

These duties provide a framework for the role and should not be regarded as a definitive list. Other reasonable duties may be required consistent with the grade of the post.

## **Qualifications and skills**

#### Essential

- A PhD in Geography or other fields relevant to critical human geography;
- A track record of peer-reviewed research outputs of internationally excellent quality relating to critical geographies of artificial intelligence and social justice;
- A successful record of obtaining external research funding a clear, compelling vision for obtaining further funding in the future;



- An ability to contribute to and develop interdisciplinary collaborative research projects in a broad range of areas;
- A proven record of delivering student education in critical human geography (including qualitative methods and research) in a university environment in both small and larger group contexts, with the ability to interact with students in ways that enhance the student experience;
- Experience of proactively developing new teaching approaches and materials in the area of critical human geography;
- A high level of interpersonal and communication skills, and a strong ability to communicate effectively in writing and verbally with students, academic and external audiences;
- An ability to contribute to management and administrative processes and structures, including managing resources and/or staff;
- Evidence of a proactive commitment to equity, diversity, and inclusion in both research and student education.

#### Desirable

- Experience of postgraduate research supervision;
- Experience working collaboratively with external partners to promote knowledge exchange and impact (e.g. civil society groups, government, etc.).
