Are you a researcher looking for your first challenge? Do you have a background in computer science, data science, electrical engineering, cyber-physical systems, or a closely related field? Do you want to further your career in one of the UK's leading research-intensive universities?

#### Overview of the Role

As a Research Fellow in Data Analysis and Security for Railway Microgrids, you will join an exciting consortium to accelerate the journey to transport decarbonisation by developing networked energy hubs for, potentially, as many as over 2,500 railway stations and depots across the UK, and extend the technology to road, ports and airports. You will be improving efficiency and supporting transport electrification with networked railway energy hubs, while offering greater flexibility to support both transport and grid operation. The project will explore the commercial opportunities to adopt and scale up networked energy hubs as virtual power plants to deliver creative, predictable, and cost-effective use of electric power on the transport while offering flexibility services to the power grid.

### Main duties and responsibilities

- Processing, cleaning, and analysing large, multi-modal datasets from sources including SCADA, IoT sensors, railway timetabling systems, and power and energy market;
- Developing robust data pipelines for ingesting, processing, and storing realtime and historical data;
- Designing, code, and test the core software platform for the microgrid energy management system;
- Implementing user-friendly dashboards for visualization of system status, performance metrics, and security alerts;
- Exploring the governance structures necessary to support secure, efficient, and compliant data sharing between the energy and rail sectors;



- Conducting threat modelling and vulnerability assessments for the railway microgrid's cyber-physical architecture;
- Generating and pursuing independent and original research ideas in the appropriate subject area;
- Developing research objectives and proposals and contributing to setting the direction of the research project and team including preparing proposals for funding in collaboration with colleagues;
- Evaluating methods and techniques used and results obtained by other researchers and to relate such evaluations appropriately to your own research;
- Making a significant contribution to the dissemination of research results by publication in leading peer-reviewed journals and by presentation at national and international meetings;
- Working independently and as part of a larger team of researchers, both internally and externally, to develop new research links and collaborations and engage in knowledge transfer activities where appropriate;
- Maintaining your own continuing professional development and acting as a mentor to less experienced colleagues as appropriate;
- Contributing to the training of both undergraduate and postgraduate students, including assisting with the supervision of projects in areas relevant to the project.

These duties provide a framework for the role and should not be regarded as a definitive list. Other reasonable duties may be required consistent with the grade of the post.

#### **Qualifications and skills**

#### **Essential:**

- A PhD (or have submitted your thesis before taking up the role) in Computer Science, Data Science, Electrical Engineering, Cyber-Physical Systems, or a closely related field; or a MSc in one of the above closely related fields with 3+ years of work experience in the relevant industry;
- Strong programming proficiency in languages such as Python (essential), with experience in relevant libraries;
- Proven experience in database management, including schema design, query optimization, and experience with both SQL and/or NoSQ technologies;



- Proven experience in data analysis, machine learning, and statistical modelling;
- Demonstrable experience in software development, including version control and writing clean, documented code;
- A solid understanding of cybersecurity principles, particularly as they apply to IoT or industrial control systems;
- Good time management and planning skills, with the ability to meet tight deadlines and manage competing demands effectively without close support;
- A developing proven track record of peer-reviewed publications in international journals;
- Excellent communication skills both written and verbal, and the ability to communicate your research at national and international conferences;
- A proven ability to work well both individually and in a team;
- A strong commitment to your own continuous professional development.

#### Desirable:

- Experience of pursuing external funding to support research;
- Experience with real-time software, embedded systems, and knowledge of industrial communication protocols;
- Experience with cloud platforms for data processing and deployment, including managed database services;
- Knowledge of data governance and data lifecycle management principles.
